**WHEREAS**, an emergency has arisen in Special Item of Appropriation in the amount of \$5,745,788.00, for the 2017 HIV Emergency Relief Project Grant and no adequate provision has been made in the 2017 Temporary Budget for the aforesaid purpose and N.J.S.A. 40A: 4-20 provides for the creation of an emergency appropriation for the purpose above-mentioned; and

**WHEREAS**, by award letter dated January 17, 2017, from the United States Department of Health and Human Services, Health Resources and Services Administration, the City of Newark has been awarded \$5,745,788.00 to provide Ryan White HIV/AIDS related health and support services to the Newark Eligible Metropolitan Area (All Wards); and

**WHEREAS**, N.J.S.A. 40A: 4-20 provides that the Governing Body by a two-thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

**WHEREAS**, emergency appropriation adopted in 2017, pursuant to N.J.S.A. 40A: 4-20 including this resolution total.....\$64,274,769.18.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE**

**CITY OF NEWARK, NEW JERSEY, THAT:**

1. A temporary emergency appropriation be and the same is hereby made for the following classification.
