WHEREAS, pursuant to <u>N.J.S.A.</u> 40A:4-19, the Municipal Council of the City of Newark adopted Resolution 7R1-h (AS) dated January 10, 2018 to provide funds for the period January 1, 2018 to March 31, 2018, and 7R1-j was adopted on March 7, 2018 to provide funds for the period April 1, 2018 to April 30, 2018, and 7R1-e was adopted on May 10, 2018 to provide funds for the period May 1, 2018 to May 31, 2018 until the adoption of the Operating Budget of the City of Newark, New Jersey; and

**WHEREAS,** additional appropriations will be required from June 1, 2018 through June 30, 2018 until the adoption of 2018 Operating Budget; and

**WHEREAS,** a previous Resolution authorizing TE #23 and prior emergency appropriations submitted for Municipal Council approval totaled \$249,525,878.49; and

**WHEREAS,** <u>N.J.S.A.</u> 40A:4-20 provides that the Governing Body by a two-thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

**WHEREAS,** TE #32 is to provide funds for the period of June 1, 2018 through June 30, 2018 until the adoption of the budget; and
