WHEREAS, an emergency has arisen in Special Item of Appropriation in the amount of \$1,000,000.00, for the Anti-Violence Project for Out of School Youth and no adequate provision has been made in the 2019 Temporary Budget for the aforesaid purpose and N.J.S.A. 40A:4-20 provides for the creation of an emergency appropriation for the purpose above-mentioned; and

WHEREAS, by Authorizing Resolution 7R1-a dated March 7, 2018, the City accepted \$1,000,000.00 from the State of New Jersey Department of Community Affairs for the 2018 Anti-Violence Out of School Youth Project: for the Newark Youth Street Academy which will target support for 60 out of school youth, who have either dropped out of school or are in serious risk of dropping out and have not succeeded in a traditional academic environment; and

WHEREAS, the project period is November 1, 2017 through March 31, 2019; and

WHEREAS, N.J.S.A. 40A:4-20 provides that the Governing Body by a two-thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and
