**WHEREAS**, the New Jersey Department of Agriculture, Division of Food and Nutrition, reimburses the City of Newark for meals served to children who live in areas in which at least 50% of the children qualify for free or reduced-price meals under the National School Lunch Program; and

No municipal funds are required for receipt or acceptance of this grant award.

**WHEREAS**, the City of Newark provides nutritious meals and snacks to children in Newark through SuNuP and is in need of additional funding to sustain the program and continue the provision of meals for Summer 2019; and

**WHEREAS**, on March 8, 2019, on behalf of the City of Newark, the Director of the Department of Recreation, Cultural Affairs and Senior Services submitted an application to the New Jersey Department of Agriculture, Division of Food and Nutrition, requesting grant funding in the amount of \$1,573,004.12 from the Summer Food Service Program to provide free, nutritious meals and snacks to children in Newark through SuNuP; and

**WHEREAS**, as a result of this application, the City of Newark has been awarded a grant in the amount of \$1,573,004.12 from the New Jersey Department of Agriculture, Division of Food and Nutrition, to provide free, nutritious meals and snacks to children in Newark through SuNuP, for the period commencing on October 1, 2018 and terminating on September 30, 2019; and

**WHEREAS**, the City of Newark must execute a grant agreement with the New Jersey Department of Agriculture, Division of Food and Nutrition, in order to obtain the grant award with no municipal funds required; and

**WHEREAS**, the City of Newark recognizes that the New Jersey Department of Agriculture, Division of Food and Nutrition, may extend the time of the grant award and/or provide additional funds if made available; and

**WHEREAS**, the New Jersey Department of Agriculture, Division of Food and Nutrition, will amend the grant to reflect the extension of the grant period and/or increase or decrease funds if made available.

# NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The Mayor and/or his designee, the Director of the Department of Recreation, Cultural Affairs and Senior Services, are hereby authorized to submit an application to the New Jersey Department of Agriculture, Division of Food and Nutrition, requesting grant funding in the amount of \$1,573,004.12 from the Summer Food Service Program to provide free, nutritious meals and snacks to children in Newark through SuNuP with no City funds required (a copy of the application is attached hereto and made a part hereof).
- 2. The Municipal Council hereby ratifies its authorization of this application from the date of application submission to the date of adoption of this authorizing resolution.
- 3. The grant award in the amount of \$1,573,004.12 from the New Jersey Department of Agriculture, Division of Food and Nutrition, is hereby accepted (a copy of letter of intent is attached hereto and made a part hereof).
- 4. The Mayor and/or his designee, the Director of the Department of Recreation, Cultural Affairs and Senior Services, are hereby authorized to enter into and execute grant documents with the New Jersey Department of Agriculture, Division of Food and Nutrition, to receive and expend the grant award in the amount of \$1,573,004.12 to provide free, nutritious meals and snacks to children in Newark through SuNuP for the period commencing on October 1, 2018 and terminating on September 30, 2019 (a copy of the Agreement is attached hereto and made a part hereof).
- 5. The Agreement between the City of Newark and the New Jersey Department of Agriculture, Division of Food and Nutrition, is hereby ratified from October 1, 2018 to the date of adoption of this authorizing resolution.
- 6. No municipal funds are required for receipt or acceptance of this grant award.
- 7. The Director of the Department of Recreation, Cultural Affairs and Senior Services shall file a fully executed copy of the grant application, letter of intent, the grant agreement, and a copy of the Certification of Funds for any required matching funds in the Office of the City Clerk.

Furthermore, this resolution ratifies and authorizes the Mayor and/or his designee, the Director of the Department of Recreation, Cultural Affairs and Senior Services, to enter into and execute an agreement with and accept grant funds in the amount of \$1,573,004.12 from the New Jersey Department of Agriculture, Division of Food and Nutrition, to provide free, nutritious meals and snacks to children in Newark through SuNuP for the period commencing on October 1, 2018 and terminating on September 30, 2019. No municipal funds are required.
