WHEREAS, the City of Newark ("City") is in need of procuring a contract for billing reimbursement and collection of Fire Rescue Services for the City of Newark, Department of Public Safety, Fire Division; and

WHEREAS, *N.J.S.A.* 40A:11-4.1(j) specifically authorizes the City to use competitive contracting to award a concession contract; and

WHEREAS, pursuant to *N.J.S.A.* 40A:11-4.3(a), in order to initiate competitive contracting, the Municipal Council must pass a resolution authorizing the use of competitive contracting each time specialized goods or services are desired to be contracted; and

WHEREAS, the competitive contracting process shall be administered by the Purchasing Agent with the assistance of the Director of the Department of Department of Public Safety and/or his designee, pursuant to *N.J.S.A.* 40A:11-4.3(b) and any contract awarded under this process shall be made by resolution of the Municipal Council, subject to the provisions of *N.J.S.A.* 40A:11-4.5(e).

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- The Municipal Council authorizes the use of competitive contracting, pursuant to N.J.S.A 40A:11-4.1 et seq., to procure a contract for the billing and collection of Fire Rescue Services for the City of Newark Department of Public Safety, Fire Division to bill and collect from insured residents and non-residents.
- 2. The competitive contracting process shall be administered by the Purchasing Agent, with the assistance of the Director of the Department of Public Safety or his designee, pursuant to *N.J.S.A.* 40A:11-4.3(b) and any contract awarded under this process shall be made by resolution of the Municipal Council, subject to the provisions of *N.J.S.A.* 40A:11-4.5(e).
