WHEREAS, the United States Department of Housing and Urban Development (HUD) has approved a total allocation of \$16,054,608.00 to the City of Newark by an approval notice dated August 27, 2019, and the Municipal Council authorized the Mayor and Business Administrator to file a new consolidated plan with HUD, which contains a request for Community Development Block Grant (CDBG) funds in the amount \$7,136,919.00, HOME funds in the amount \$2,467,446.00 Housing Opportunities for People with AIDS (HOPWA) in the amount of \$5,841,359.00 (on behalf of Newark and the "Eligible Metropolitan Area"), and Emergency Solutions Grant funds in the amount of \$608,884.00, in compliance with Federal statutes and regulations governing the four aid grant programs; and

WHEREAS, by resolution 7R1-a, dated November 7, 2019 the Municipal Council authorized the Mayor and the Business Administrator to enter into four separate agreements with HUD to receive and expend FY 2019 Community Development Block Grant funds in the amount of \$7,136,919.00, HOME funds in the amount \$2,467,446.00 Housing Opportunities for People with AIDS (HOPWA) in the amount of \$5,841,359.00 (on behalf of Newark and the "Eligible Metropolitan Area"), and Emergency Solutions Grant funds in the amount of \$608,884.00; and

WHEREAS, the City of Newark desires to establish the block grant program and appropriate the funds to the various sub-grantees.
