**WHEREAS**, on September 12, 2019, the City of Newark, Department of Engineering, Division of Traffic and Signals, advertised for receipt of bids, for Contract No. 2019-02, Installation of Pavement Markings on Various Streets in the City of Newark; and

**WHEREAS**, on September 25, 2019, the Department of Engineering received two (2) bids for Contract No. two (2), Installation of Pavement Markings on Various Streets in the City of Newark, in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

**WHEREAS**, based on a review of the bids, the Director of the Department of Engineering, desires to award Contract No. 2019-02, Installation of Pavement Markings on Various Streets in the City of Newark, to the lowest bidder, Statewide Striping Corporation, 499 Pomeroy Road, Parsippany, New Jersey 07054, for the total bid amount of \$239,250.00.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. The Mayor and/or his designees, the Director of the Department of Engineering, are hereby authorized on behalf of the City of Newark, to accept the bid proposal submitted by the lowest

responsible bidder, Statewide Striping Corporation, 499 Pomeroy Road., Parsippany, New Jersey 07054, and execute Contract No. 2019-02, Installation of Pavement Markings on Various Streets in the City of Newark, for the total bid amount of \$239,250.00.

2. Attached hereto is a Certification of Funds from the Director of Finance of the City of Newark which states, (1) that there are available sufficient legally appropriated funds in the amount of \$239,250.00 for the purpose set forth hereinabove, and (2) that the line appropriation of the official budget which shall be charged is as follows:

7. The public bidding process under the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq., complies with the Fair and Open Process of the State of New Jersey Local Unit Pay-to-Play Law, N.J.S.A. 19:44A-20.5, et seq.
