WHEREAS, the Municipal Council has indicated its support of Homestead Park Block Party, to be held at Homestead Park between Hawthorne Avenue and Clinton Avenue, on Sunday, August 21, 2022 (Rain Date: Saturday, August 27, 2022) from the hours of 11:00 A.M. until 10:00 P.M.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. The Municipal Council does hereby indicate its support of the Homestead Park Block Party, to be held at Homestead Park between Hawthorne Avenue and Clinton Avenue (South Ward), on Sunday, August 21, 2022 (Rain Date: Saturday, August 27, 2022), from the hours of 11:00 A.M. until 10:00 P.M.

The Municipal Council is co-sponsoring this special event and waives the City of Newark's Special Event Permit Application Fee of Fifty Dollars and Zero Cents (\$50.00), however, it does not waive insurance coverage requirements due to be provided by event organizers or costs above service charges described in R.O. 5:10-1 et seq.
