**WHEREAS,** a previous resolution authorizing TE #34 and prior emergency appropriations was submitted for Municipal Council approval totaled \$350,208,744.61; and

**WHEREAS**, N.J.S.A. 40A: 4-20 provides that the Governing Body by a two-thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and
