N.J.S.A. provides Division WHEREAS. 40A:4-87 that the Director of the Local Government Services may approve the insertion of any Special Item of Revenue in the budget of any local unit when such item shall have been made available by law and the amount thereof shall not have been determined at the time of the adoption of the budget, and may approve the insertion of an appropriation item of equal amount for the purpose of carrying out the purposes of the law making such item of revenue available for expenditure; and

WHEREAS, the State of New Jersey, Office of Homeland Security and Preparedness has made available \$1,648,221.00 to provide funds for the UASI program; and

WHEREAS, by an award letter dated September 1, 2022 from the State of New Jersey, Office of Homeland Security and Preparedness, the City was awarded \$1,648,221.00 for the UASI Program.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. In accordance with the provisions of <u>N.J.S.A</u> 40A:4-87, the City of Newark, New Jersey hereby requests the Director of Local Government Services to approve a budget insertion in the amount of \$1,648,221.00 and an appropriation of an equal amount for the FY 2022 Urban Area Security Initiative (UASI) in the budget year 2022 as set forth in Schedule A, attached hereto and made a part hereof.

- 2. The aforesaid insertion is, in the opinion of the Governing Body, warranted and authorized by N.J.S.A. 40A:4-87 and are necessary for the orderly operation of the municipality.
- 3. A copy of this Resolution shall be filed with the Director of the Division of Local Government Services by the Acting City Clerk.

STATEMENT

This Resolution is establishing an appropriation and revenue in the amount of \$1,648,221.00 for the FY 2022 Urban Area Security Initiative (UASI). The State of New Jersey, Office of Homeland Security and Preparedness is providing these funds. The project period is September 1, 2022 through July 31, 2025.
