AN ORDINANCE AMENDING TITLE 2, ADMINISTRATION, 2 3 CHAPTER 2 OF THE REVISED ORDINANCES OF THE 4 CITY OF NEWARK, NEW JERSEY, 1966 AS AMENDED AND SUPPLEMENTED. (BY CHANGING THE "COMMITTEE 5 ON THE STATUS OF WOMEN" TO "COMMISSION ON 6 THE STATUS OF WOMEN" AND FURTHER FORMALIZING THE PARAMETERS OF THE COMMISSION. of Women and WHEREAS, the City of Newark recognizes the significance in our society, and their changing and developing role; WHEREAS, by Ordinance 6S&FA (S-1) adopted July 16, 1986 the Municipal Council reestablished the committee on the status of Women; and WHEREAS, the City recognizes the need to formalize the parameters of the Committee and to upgrade the committee to a commission and more specifically define the responsibilities and objectives of the committee. NOW THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT Section 1.
